This will require an increase to our budget line of \$704.41. The monies would have to be taken from our current books budget.

They were told of the upcoming approval of a new Plan of Service and seem to be on board with the goals we presented. I also briefly went over the draft of our new employee handbook. - In a conversation that I had with a staff member at RCLS it was suggested that we write a letter to the Town Board stating our interest in obtaining the downstairs space. While in its current state it is not usable for any of our collections the staff and I would like to create a larger programming area. We have spoken about updating the bathrooms,

expanding the kitchen for more hands on classes, installing a better sound system and possibly a projector system. My understating is that the new Center is supposed to be complete by the end of the year. While I have made known my intentions to the Town Supervisor, I have to agree that presenting our intentions in writing should be our action at this time.
